

Rules:

1. "Bagažinių turgus" is an event, the purpose of which is to bring together traders selling unnecessary, but interesting, useful and valuable items.
2. "Bagažinių turgus" participant is an entrepreneur, natural or legal person.
3. During Bagažinių turgus, the participant must pay the participation fee to the organizers of "Bagažinių turgaus" - UAB "Urmo prekybos miestelis".
4. During "Bagažinių turgus", participants come together and sell items from their car trunks or near them. Traders present their used items, which are no longer needed. These items of the same or different types are exchanged or sold at an agreed price.
5. Participant of "Bagažinių turgus" must present clean items, so that they are harmless and safe.
6. It is PROHIBITED for the participant of "Bagažinių turgus" to:
 - Present items that have been acquired illegally.
 - Present items whose retail sale or supply is prohibited by law and other regulatory acts.
 - Present items whose retail sale or supply is licensed.
 - Present non-animal food products - these are products obtained from plants and/or their parts, used for food: plants and their parts, cereals, edible vegetables, edible fruits, berries, mushrooms and products made from them.
 - To sell or exchange animals and animal food products or food products obtained and/or produced from animals: manufactured products, milk and dairy products, poultry eggs, natural honey.
 - Sell new items, clothes, cosmetics, perfumes, if they make up more than 20% of all available items.
7. The participant of "Bagažinių turgus" must comply with the rules of public order, fire protection rules, maintain cleanliness and observe hygiene norms.
8. "Bagažinių turgus" working days: if "Urmos Prekybos Miestelis" is open, the "Bagažinių turgus" is also open (even when the working hours of the "Urmo Prekybos Miestelis" are reduced). If "Urmo Prekybos Miestelis" is not open, neither is "Bagažinių turgus". "Bagažinių turgus" is always a paid event.
9. People under the age of 18 may exchange or sell items only with adult supervision.
10. We expect you to exchange or sell the following items at "Bagažinių turgus": clothes (for children and adults), footwear, second-hand items, crockery, numismatics, antiques, household items, self-made items, sports and leisure items, audio recordings, books and other such items.
11. A participant who does not comply with these "Bagažinių turgus" rules or other requirements of the organizer or legal acts may be removed from "Bagažinių turgus" by the organizer's unilateral decision, and the participant may not be allowed to trade in "Bagažinių turgus" in the future. The participation fee paid by the participant is not refunded.

12. "Bagažinių turgus" participant agree that while participating in "Bagažinių turgus", they will be photographed and/or filmed, and the image (photo) and/or footage is transferred to "Urmo prekybos miestelis" UAB and "Urmo prekybos miestelis" UAB is the legal manager of the image (photo) and/or footage, for the purposes of presenting, publicizing and informing third parties of the activities carried out by "Urmo prekybos miestelis" UAB and it would be published on the website and social network accounts of "Urmo prekybos miestelis" UAB. The participant of "Bagažinių turgus" also agree that the image (photo) and/or footage could be provided to third parties, for example, photographers and videographers with whom "Urmo prekybos miestelis" UAB has concluded an agreement to provide photography and video recording services.
